Background and Purpose

First 5 Trinity County Children and Families Commission is required to submit an annual report to First 5 California to “provide a summary of county Commission revenues, expenditures, and population served as required by the California Children and Families Act (Health and Safety Code, Sections 130100–130155). The First 5 California Annual Report (AR) contains three sections:

AR-1: County Revenue and Expenditure Summary

The County Revenue and Expenditure Summary form (AR-1) captures First 5 county commission fiscal data showing the relationship between financial resources and services. The fiscal data must be consistent with Generally Accepted Accounting Principles (GAAP) and each commission’s audited financial statements.

The following outlines the requirements for completing the AR-1:

- The revenue Detail section must include total revenue from tobacco tax, First 5 California funds, other public funds (federal, state, local), and additional revenue from sources such as services, grants, and donations. County commissions receiving Small Population County Funding Augmentation (SPCFA) must report these funds as revenue but are no longer required to include additional SPCFA detail when reporting expenditures. County commissions must specify the total expenditures and people served (children, primary caregivers, providers) by result area with additional breakout by Service Category and Grantee Type. To the extent possible, counts of children, primary caregivers, and providers should be unduplicated at the level of the Grantee Type.

AR-2: County Service Demographic Worksheet

The purpose of the County Demographic Worksheet (AR-2) is to capture demographic information about the populations served by each First 5 commission at the county level.

The following outlines the requirements for completing the AR-2:

- Provision of unduplicated counts of populations served within the county including breakdowns by population category, race/ethnicity, and primary language spoken in the home. To the extent possible, counts of persons served should be unduplicated for AR-2. Commissions should aggregate number of persons served across Results/Services/Grantee Types reported in AR-1 to complete the Demographic Worksheet. Because duplicated counts are allowed in the AR-1, the total number of persons for demographic data reported in the AR-2 should be the same or less than the number of persons reported in the AR-1

AR-3: County Evaluation Summary and Highlights

This section provides a standardized format for each county commission to submit information about evaluation activities completed and findings reported in its Annual Evaluation Report or other evaluations conducted during the fiscal year focusing on all four Result Areas: Family Functioning, Improved Child Development, Improved Child Health, and Improved Systems of Care. County highlights describing accomplishments during the fiscal year also are reported and will be published in F5CA’s Annual Report

The following outlines the requirements for completing the AR-3:

- **Evaluation Activities Completed:** Provide a description of evaluation activities completed, evaluation findings, and their policy impact during the fiscal year.
County Highlights: Provide two or three highlights or accomplishments that occurred during the fiscal year.

All completed data submission forms are due to First 5 California by 11:59 pm on October 31, 2022. The following pages contain information that is necessary for submission to First 5 California as an element of the Annual Reporting process. Only information that is gathered as a component of evaluation efforts are provided in this document.

Evaluation Activities Completed

In fiscal year 2022-23, Trinity County's First 5 Commission continued to focus on improved data collection and increased service provision.

Trinity Smiles developed a sustainable plan for operating, maintaining, and staffing a future mobile dental van through various collaborations with community partners. Trinity County Office of Education and Trinity County Public Health Local Oral Health Program (TC-LOHP) are working together to purchase an equipped Trinity Smiles mobile dental van to provide dental services and treatment directly school sites throughout Trinity County. In collaboration with TC-LOHP, implementation and sustainability plans have been created and partnerships with dental providers and/or a Registered Dental Hygienist in Alternative Practice (RDHAP). Trinity Smiles successfully completed Kindergarten and Transitional Kindergarten oral health assessments at all school sites in Trinity County. Trinity Smiles also adopted passive consent, as opposed to active consent forms, meaning that parents only had to return the permission form if they were declining the oral health assessment for their student. Resultingly, the number children who received oral health assessments by a dental professional more than doubled, in comparison to the previous school year. Parents expressed gratitude about the oral hygiene kits provided by our local oral health program, in particular the hourglass sand timers and a "monkey book" that provides a reward chart for brushing and flossing twice each day.

School readiness continues to expand with their robust and unifying goal of "Family Engagement." The county Office of Education launched their Professional learning series and cross-program training opportunities, which have been well-received. Bolstering visibility and community engagement has led to increased community interest and enrollment. All five (5) program sites in the county are open with strong educators at the helm.

The Welcome Baby Program experienced an increase in services offered this year and continues to assess how to improve their referral system and for new opportunities to engage new parents and assist with home assessments to increase family safety.

The First 5 Trinity County Children and Families Commission invests in a variety of services aimed at supporting children prenatal through age five and their families. Primary investments include School Readiness, Trinity Smiles, and a Welcome Baby program.

- Strengthen efforts to equip parents as their child’s first teacher. This combined with the school readiness assessment results indicate that additional supports and resources, specifically in the area of literacy and numeracy could benefit children and families.
- Support the operational plan of Trinity Smiles and work to support collaborative partnerships across the county.
- Identify a referral and resource approach to providing supports to families with infants and toddlers. First 5 has historically funded the Welcome Baby program in an effort to serve families with the youngest of children,
